QVC/HSN and etc. Est. Value: \$100,000 Both Alice's email accounts (along with credit cards and travel rewards programs) were hacked into after the accident.

After much trial & tribulation, we were able to access Alice's AOL account. However, Apple locked the iCloud account completely (as also happened with the credit card companies).

Though Alice preferred shopping at local places and while traveling (which they did profusely since retiring in 1997), she was an avid customer of televised home shopping. Eventually, she learned to shop the internet online (which from the AOL email account are the only receipts we could obtain). Primarily as sampled in these receipts we downloaded, she bought Jewelry and clothes:

We estimate in the last 10 years, as Alice and Jim traveled less frequently, they spent an average of \$10-20K on Jewelry via televised and internet shopping, which equates to a minimum of \$100k.

The following are estimates (beyond what was previously listed above):

Prizes/Gifts/Family Bequests: Alice & James both inherited jewelry from relatives and purchased locally much jewelry prior to retiring. Kelly and Steve both remember their dad on a TV game show (Hollywood Squares & High Rollers) winning thousands in jewelry (specifically Kelly remembers a Tiffany diamond bracelet, matching necklace, and Diamond Dice Ring). Also, Alice Sharp gifted her niece continually while living since Alice Mitchell's mother died at birth. Alice was only of two of Mr. & Mrs. Sharp's kin. We estimate the jewelry portion was worth a minimum \$100,000.

Purchases While Traveling: Alice & James purchased many timeshares and loved

to make many cruises in their lives after retirement. Alice & James spent a minimum of 10-20K a year on jewelry since 1997 (after retirement) while traveling extensively. We estimate the total worth to be a minimum of \$200,000
