Kelly,

I have a copy of the Federal estate tax return that was filed for the Estate of Alice Sharp. Your mother was bequeathed the tangible personal property. There are three entries on the return with appraisals: (1) Goods and chattels - \$43,986.50; Coins and currency - \$28,633.23 and Jewelry - \$3,990.00. I have sent you these appraisals. I have no other information or appraisals regarding any other paintings than those included in the goods and chattels appraisal.

I have spent the better part of this morning trying to see if Mary Griffin, Vice President at Harris Bank, the Co-Trustee of Alice Sharp's trust, is still at the Bank. I have not yet been able to even reach the right department. It is highly unlikely she is there and given that the estate is 21 years old, I do not know if the Bank would even have any records.

I have no knowledge of where the paintings would have come from. Again, if Alice Sharp owned paintings at the time of her death, they would have been appraised, included on her Federal estate tax return, and distributed to your mother. I have nothing else other than what I sent you.

I am sorry I cannot be of any further help. Bev
